One of Thomson's most passionate causes is Big Dog Ranch Rescue, where he serves as Vice President on the Board of Directors, actively supporting fundraising, networking, and marketing efforts. In July 2023, he generously underwrote \$10,000 in adoption fees during the Christmas in July Adoption Event, benefiting local military and first responders. In 2019, he made a substantial \$50,000 donation to the building fund. Most recently, Thomson took on the role of Presenting Sponsor for the 2024 Tico Torres Celebrity Golf & Tennis Classic, an event where 100% of the proceeds support Big Dog Ranch Rescue.

#### **Spreading Joy During the Holidays**

Rob Thomson's philanthropic spirit shines brightly each holiday season. In 2004, he established Charities for Children, an organization dedicated to delivering holiday presents to underprivileged children throughout Palm Beach and Martin Counties. Thomson and his volunteers distribute thousands of toys to churches and schools during the holiday season, up to 1,000 Easter baskets each spring, and hundreds of brand-new bicycles every December to children in Riviera Beach, Florida. Bishop Thomas Masters, former mayor of Riviera Beach, commends Thomson's generosity, noting, "Local children look forward each year to Rob's generous donation."

## **Investing in Education and Accessibility**

Thomson's commitment to making a difference extends to education. In 2020, he led fundraising efforts and matched community donations dollar-for-dollar to provide special needs students at Jupiter High School with a much-needed ADA-compliant school bus, significantly improving their transportation experience and benefiting the Exceptional Student Education Program. Currently, Thomson is spearheading efforts to deliver another ADA-compliant school bus for special needs students at Dwyer High School, with delivery anticipated for January 2025.

#### **Honoring Community Heroes**

Rob Thomson's appreciation for first responders is unwavering. In 2021, he built two state-of-the-art workout facilities for the Juno Beach and Tequesta Police Departments, earning him the Community Partnership Award, a key to the city from the Juno Beach Police Department, and the Special Recognition Award from the Tequesta Police Department. In 2023, he was recognized as a Platinum Sponsor by the First Responders Appreciation Foundation for his \$7,500 donation.

## **Supporting Youth Battling Addiction**

Thomson's generosity also reaches young individuals facing addiction challenges. In honor of his late son, Bradley Boyer, he donated \$100,000 to The Hanley Foundation, an organization providing scholarships for rehabilitation programs. His nomination to the Hanley Foundation Board in 2023 reflects his ongoing commitment to supporting youth in need. Current Chairman Chip James praised Thomson's nomination, stating, "Rob has been a fixture in the community for years. He puts his heart into each organization he supports, and I know he will have a positive impact serving on the board."

## **Empowering Local Children and Families**

Place of Hope, a child welfare organization dedicated to ending cycles of abuse, neglect, homelessness, and poverty for children, youth, and families, holds a special place in Rob's heart. During COVID-19, Thomson donated \$20,000 to their Cruise for Kids initiative, providing suitcases filled with vacation goodies and organizing fun-filled days for the children. Charles Bender, CEO of Place of Hope, speaks highly of Thomson's commitment: "Every time I ask him to be a part of something, he says yes. He's not only willing but enthusiastic to help when the children need assistance."

#### **Investing in Healthcare**

In 2024, Thomson demonstrated his support for local healthcare with a \$25,000 donation to Jupiter Medical Center, committing to contribute an additional \$75,000 over the next three years. His goal is to enhance the center's services, reach more individuals in need, and provide excellent medical care to patients, reflecting his dedication to improving community healthcare.
